

# WARRANTY

## OWL POWER SOLUTIONS PRODUCTS LIMITED FIVE-YEAR WARRANTY

### **What this Limited Warranty Covers and For How Long:**

Owl Power Solutions (OPS) warrants that the product accompanied by this limited warranty is free from manufacturing defects in materials and workmanship for a period of five (5) years from the date of original purchase as shown on your invoice or sales receipt. This warranty is only extended to the original consumer purchaser of the product.

### **Disclaimer of Implied Warranties Beyond the Limited Warranty Period:**

The limited warranty period of five (5) years also applies to any implied warranties that may exist under applicable law, including the implied warranties of merchantability and fitness for a particular purpose. There are no warranties that extend beyond the description on the face hereof.

### **What this Limited Warranty does not Cover:**

This limited warranty does not apply to defects resulting from (1) overloading, misuse, abuse, alteration, accident, neglect, improper maintenance or handling, repeated installation and removal, or normal wear and tear; (2) improper installation; (3) installation in an improper environment; and (4) any use that is not under normal operating conditions or not in accordance with any product packaging, warnings, or instructions for use.

### **What Owl Power Solutions will do:**

If you believe the product is defective, please return it to OPS in the manner described below within the limited warranty period of five (5) years from the date of purchase along with the original receipt. If OPS determines there is a defect covered by this limited warranty, OPS will, at its option, repair or replace the product or components of the product. This limited warranty extends to repaired and replacement products and components only through the end of the original limited warranty period.

### **Limitations of Remedies under this Limited Warranty:**

The remedies provided herein are the exclusive remedies under this limited warranty, whether based on contract, tort or otherwise. In no event will OPS or any of its retailers, dealers, distributors or resellers be liable for incidental, indirect, special or consequential damages relating to the product (including any repaired or replacement product or component), its use, or its installation, including without limitation damage to, or loss of use of, any equipment, lost sales or profits or delay or failure to perform this warranty obligation. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
